

A second resident living at a Norwood-based, assisted living complex for persons with a mental illness has been arrested, this time for a "lewd act" aboard a subway last month, police said. It follows a prior arrest of another resident of the same complex, located at 3525 Hull Avenue, for the 2021 slashing of a senior with a boxcutter.

According to its website, the Postgraduate Center for Mental Health (PCMH) was founded in 1945, is a "major developer of housing for persons with mental illness," owns 17 apartment buildings across New York City, and "is expanding its commitment to reducing homelessness among the City's most vulnerable citizens."

The \$17.4 million Hull residence opened in February 2012, according to PCMH's website, and is for applicants only referred by NYC Department of Homeless Services (DHS) and NYS Office of Mental Health (OMH) who meet specific program requirements, as well as community tenants who applied [for residency]. On-site case management and clinical services are available.

On Wednesday, Dec. 11, 2024, the NYPD shared a photo on X of a man sitting in a subway train with a caption that read, "At 8.25 a.m. a 25-year-old female was on board a southbound "A" train at Chambers Street Subway Station [Manhattan] when an unknown male performed a lewd act in front of her." On Sunday, Dec. 29, 2024, police announced Wesley Anderson, 42, of 3525

### Kingsbridge Fire Injures Two FFs & Displaces 45 Residents

Two firefighters were treated for minor injuries after a four-alarm, residential fire broke out in Kingsbridge on Wednesday night, Jan. 15, displacing dozens of residents. The FDNY said the department received a call at 5.56 p.m. for reports of a fire on the fourth floor of a 4-story building at 3030 Heath Avenue between Albany Crescent and Summit Place, a few hundred feet from Local Ladder 46 firehouse at nearby Bailey Avenue and Heath Avenue.

FDNY Assistant Chief Kevin Woods, chief of operations, said the affected multiple dwelling was a non-fireproof, Class 3, H-type building [60 X 60] comprising 6 apartments on each floor. FDNY officials said a 2nd alarm was raised at 6.10 p.m., a third alarm at 6.15 p.m. and a 4th alarm at 6.40 p.m. They said 39 units, comprising 168 fire and EMS personnel responded to the blaze, which according to Diana Finch from the Bronx Park East Community Association, could be seen from the 9<sup>th</sup> floor of her building in the East Bronx.

The FDNY said the blaze was brought under control at 8.08 p.m. and FDNY fire marshals are investigating the cause. Woods later said in part, "We arrived here in under four minutes. Upon arrival, we had heavy fire on the top floor, the cockloft [the space between the ceiling of the top-floor and the roof], and through the roof."

According to APX Data, in firefighting, the cockloft can present a significant hazard to firefighters. At another recent residential fire on Jan. 10 at 2910 Wallace Avenue in Allerton, which displaced hundreds of residents, the fire had also extended to the cockloft." Woods added, "Our engine companies moved in very aggressively, stretching multiple hand lines to that top floor and also to the roof. Our ladder companies also did a phenomenal job opening up many of the voids in that cockloft and cutting open the roof."

Woods said the work was exacerbated by the wind which he said pushed the fire across the cockloft, which he said was undivided. "With this weather, as soon as this water hits the ground, of course it freezes upon impact," he added. Asked if there was construction happening inside the building, the chief said there was not.

Asked if they had made any rescues, Woods confirmed they had not and that everyone self-evacuated. Asked about the 4-alarm nature of the fire, he said in part, "Firefighting is extremely physically demanding. It's labor-intensive and the constant relief of the units, the amount of fire, and the amount of apartments that are involved, it's just very labor-intensive.....hence the fourth alarm." Asked if the cause was potentially suspicious, Woods said it was under investigation.

He added in part, "There are no injuries to any of the occupants. There is extensive damage to approximately six to eight apartments." He said the fire units prevented further extension and damage.

We spoke to Miguel, the building's super, who lives in the basement with his family. Speaking in Spanish, he said everyone had been evacuated. Residents and neighbors were seen standing in the cold on the icy streets on an evening where temperatures had dropped to 28 degrees Fahrenheit. Asked if he knew how the fire started, Miguel said, "I don't know. I'm ok. I was downstairs." He said his family were also ok. He said residents on the third and fourth floors couldn't return due to the fire damage and seemed to believe residents on the lower floors could.

A Red Cross spokesperson later said it had initially registered 17 households and 34 individuals (of which four were children) for emergency housing. "Our Disaster Action Team also provided meals, blankets, toiletries, and other care items to impacted residents," the spokesperson said, adding that anyone who was unable to connect with the Red Cross should call 1-877-RED CROSS (877-733-2767) and select option 1.

On Jan. 16, the Red Cross said a full vacate order was in effect and referred us to NYC Department of Buildings (DOB) for more details. When contacted, DOB officials said inspectors were called to the scene to conduct a structural stability inspection, which determined the building sustained extensive structural damage, "including charred wood joists, a partially collapsed roof, collapses of interior walls, and broken windows."

They said the building was deemed unsafe for people, and all displaced residents were therefore also offered emergency relocation assistance by the Red Cross. "The Vacate Order will remain in effect until such time as the owner makes the necessary repairs to make the building safe for occupancy," they said, adding that DOB inspectors were back the next morning, working with partner agencies to conduct additional inspections and cleanup operations.

According to DOB records, there are open violations for the building with civil penalties due. Since Sept. 23, 2024, there was an open, active low pressure boiler violation number 06078. On June

1, 2021, another Construction / Plumbing (OATH/ECB) violation number 39042008N was recorded for failure to maintain the building in a code-compliant manner. The notes read, "Observed on second floor apartments 2A and 2C in the kitchen area behind gas stoves, no gas valve, repair and replace."

As of Jan. 15, a new construction violation number 25-00064 was recorded with the following update, "Structure rendered non-compliant at time of inspection, observed severe fire, water & smoke damage throughout entire premises along with windows out, large sections of roof missing. Severe charring to structural wall/ceiling framing. Exposure #1 (Heath Ave) parapet wall severely leaning forward."

The Red Cross later revised the number of residents they assisted, saying, "As of 3 p.m. today [Jan. 16], we are now at 21 households consisting of 45 individuals (of which seven are children)."

On the evening of the fire, two MTA "Out of Service" buses were seen being waived past a police vehicle on Bailey Avenue, likely called to pick up residents and transport them elsewhere. A Red Cross official was overheard talking to an official we believe was with NYC Department of Emergency Management about the possibility of relocating residents to a local school for registration.

Fire and emergency units could be seen all along Bailey Avenue from at least 230th Street, and the NYPD had blocked off the other end of Bailey Avenue at 231st Street. Meanwhile, Heath Avenue was also blocked off by the NYPD to vehicular traffic at Summit Place as more fire units, a Con Ed vehicle, and emergency vehicles almost filled the street to Bailey Avenue. An official from NYC Department of Sanitation was also seen at the site of the fire. Asked if a fire alarm had gone off, Miguel said, "No, no, no."

We spoke to three other female residents, two of whom were just coming home from work to find the building on fire and one of whom had been inside in her third-floor apartment when the fire broke out. They all said they and their families were safe. One of the residents commented that it was a "lucky" time that the fire broke out as most people were at work.

The female resident who declined to be identified who had been inside her apartment appeared slightly traumatized by the event. Speaking in Spanish, she said, "Everyone is safe, thank God. I was inside and when I saw the smoke, I left. The fire was upstairs on the fourth [floor]. I opened the door by the kitchen, I saw a fireman, and I yell to my daughter, 'Run out of your room! Let's go! There's a fire upstairs!'''

She added, "We went to the next-door neighbor. She says, 'Stay here,' but they started to go downstairs. I heard the neighbors calling, 'Run, Madam!' and we went down the stairs. I was nervous when I saw the smoke. No one got hurt. I'm still nervous. I have not moved from where I am right now."

Asked if she knew what started the fire, she said, "No, because it was upstairs. I don't know." Asked if it had been difficult getting out with the smoke, she said there was water and glass falling down on top of them from the higher floors. Asked if she had seen any injured people, she said, "No, no, no, it was calm." Asked if she recalled hearing a fire alarm go off, she said she didn't but heard the firefighters outside.

We asked the FDNY about alleged reports that no fire alarm was heard by some residents, and they responded, saying, "Part of the investigation conducted by Fire Marshals." The building owner, according to City records, is MGSA IV LLC, with an address in Cedarhurst, NY. The building was constructed in 1926.

Based on NYC Department of Housing, Preservation & Development (HPD) records, there are three, open, repair-

related complaints as of the date of publication for the 3030 Heath Avenue, and no complaints closed since the date of the fire. Meanwhile, HPD records 260 open violations, five citing heat/ boiler issues, and one additional boiler-related one.

A similar named entity, MGSA III LLC, owns nearby 3021 Heath Avenue which, according to HPD, has 399 open violations, while MGSA II LLC owns 3004 Heath Avenue which has 229 open violations, MGSA I LLC owns 160 West Kingsbridge Road in in Fordham Manor, which has 291 open violations, and MGSA VII LLC owns 2487 Grand Avenue in Fordham Manor, which has 312 open violations. Norwood News was unsuccessful in our attempts to reach MGSA III LLC for

## BRAC Unveils First 2025 Gallery Opening

The Bronx River Art Center (BRAC) opened its first gallery of 2025 to the public entitled, "*Between Inspiration and Collecting: The Artist's Cabinet*," on Thursday, Jan. 9. The gallery showcases various artists' personal collections and reveals how they shape their creative vision.

Officials said the exhibit aims to challenge the notion that art collecting is for prestigious institutions, or for the ultra-wealthy by turning attention to the personal collections of 12 selected artists.

Alena Alekseeva, BRAC exhibitions coordinator and curator of this exhibit, said, "This show is not just a showcase of the artists' work, it's also a showcase of their personal collection. So, my goal was to show how artists can collect what they collect and how it influences the work that they do. So, I gathered 12 artists here to show their [process] and their collection pieces."

Alekseeva said the 12 artists selected were chosen after receiving more than 70 applications. "My vision for the selection process was to see how artists understand what they do and how they relate to their art and their collection," said Alekseeva.

The exhibit features the artists' collections of Amy Talluto, Anna Fine Foer, Chris Baker, Katia Rozenberg, Jude Griebel, Tatiana Mesa Paján, Robbii Wessen, Sahar Alizadeh, Sheldon Campbell, Stephanie Germosen, Sor Elizabeth Ochoa-Zavala, and Ying Hung.

Paján described her personal collection as "notes taken from the streets of Havana, Cuba." She said it consists of broken texts found across the city, including messages, letters, secrets, and more that show the life of the city through these texts.

The exhibit will be on display in the Bronx River Art Center's main gallery until Saturday, Feb. 15, and is located at 1087 East Tremont Avenue in the West Farms section of the borough.

"The building gets heat, but some people in the building don't get heat. When my mom turns her heat on, it lasts for like seven minutes and then it starts blowing cold air for no reason. That's been for the past 14 years, and then the super comes upstairs and fixes whatever. I think something's wrong with the thermostat. The thermostat always reads between 75 and 80 degrees and it's not true; the apartment is still cold. My mom called 311 about three times; nothing happened."

"I'm not getting enough heat because every time when it's below zero degrees, they don't turn on the heat. They only turn on the heat when it's like forty degrees outside. That's when the supper of my building turns on the heat. The heat only comes on if they turn it on and sometimes, they don't. I think they're trying to save money on gas because they don't want to spend the money. No, we haven't called 311. I use a space heater to keep me warm, and that's dangerous."

"I'm a resident here in The Bronx and I've been seeing a lot of reports with people complaining about the lack of heat, even though they pay rent. These people need heat, and landlords need to update their boilers. And they should limit the heat in each apartment, because a lot of people like to abuse and use more heat than a regular tenant. And sometimes, the landlords want to be cheap and they don't want to fix things, and they act like it comes out of their pocket, but everybody is paying rent."

## Webster Ave Post Office Shut for 3-4 More Weeks

The USPS post office located at 2963 Webster Avenue and Botanical Square in Bedford Park has been closed since a large water main break caused major flooding back on Monday, Dec. 16, 2024. USPS now says repairs to the damaged building could take as long as a month before it's back up and running.

When contacted on Tuesday, Jan. 21, Xavier Hernandez of the USPS strategic communications team told Norwood News, "The contractor has begun working on repairs to extensive flood damage at Botanical Station." He added, "If all goes well, we expect the work to be completed within the next three to four weeks. Once completed, we expect regular retail service to begin shortly thereafter."

On the same day, we spoke to "David," a resident of Botanical Square, whose building remains without elevator service or gas for his oven since the flooding. David had already learned about the post office's closure, saying, "Yeah, that's what they say because they're taking their sweet time to do anything in there."

He alleged, "I know the owner of the place and the post office isn't letting him send a crew in there to do it. The post office is using their own crew and they're taking their sweet time to do anything in there."

He continued, "And it's bad for us, because the post office there was convenient for everybody around here. Now, we have to go to [East] 204th Street and [East] Mosholu Parkway [North] to the post office over there, or we have to go to the one on [East] 188 Street and Third Avenue, and if you go to the one on Third Avenue, you're going to be there for up to an hour."

As reported, Norwood residents were previously very frustrated over the length of time it took to reopen the Jerome Avenue post office branch located by East Gun Hill Road after it was temporarily closed in recent years due to a raccoon infestation. On that occasion, Norwood News received conflicting reasons from USPS and the building owner for why it took so long to reopen the branch, which did eventually reopen.

We sent some follow-up questions to Hernandez on David's claims about the workers at the Webster Avenue branch. We had not received a response as of press date but will share any updates we receive.

## Spuyten Duyvil: MTA Bus Hits Wall on Black Ice

There were no injuries reported after a BxM1 bus crashed into a high wall by 2601 Henry Hudson Parkway and Kappock Street / Independence Avenue in the Spuyten Duyvll section of The Bronx on Friday morning, Jan. 17, according to City officials. The FDNY said on Friday they received a call at 8.40 a.m. for a report of a bus hanging from an overpass. They said there were no reported injuries, but emergency units remained at the scene. The MTA later confirmed the FDNY helped the driver off the bus.

When contacted, an NYPD spokesperson said at 8.40 a.m., upon arrival at Independence Avenue and Kappock Street, officers from the 50th Precinct were informed that a 57-year-old, male, MTA bus driver was traveling southbound on the Henry Hudson Parkway West when he failed to navigate the roadway and lost control of the bus, missing its turn and skidding over the stone wall. "There were no injuries reported," the spokesperson added.

Asked if the bus had been occupied at the time with many passengers, the spokesperson said, "I don't have that detail at the moment." We asked the MTA if they could confirm this information. A spokesperson later responded, saying, "The incident involving a BxM1 bus was reported at 8:32 am at Kappock and Henry

#### Hudson Parkway."

The MTA spokesperson added, "No customers were on board at the time. No injuries have been reported." Asked if there were any other vehicles involved in the accident, the NYPD spokesperson said it was just the bus.

Some videos of the scene were shared with *Norwood News* by local resident, Stephanie Coggins, and can be viewed on the online version of this story on our website.

TWU Local 100 MTA Bus Vice President Danny D'Amato, Division Chair Mike Capocci, Yonkers Depot Chair Marcus Soler and TWU Safety Team members Joseph DiPaola and Jamie Ayuso later said they also responded to the scene. They said the 26-year-veteran bus driver at the wheel had been attempting to pass a poorly parked vehicle obstructing a narrow single lane service road.

They said the bus slid on black ice into a ditch, and the front wheel hit a guardrail, damaging a stone wall abutting the Henry Hudson Parkway. "The Bus was safely removed by the TWU Local 100 road service crew with the help of FDNY," they said. "Vice President D'Amato said the operator is shaken up by this unfortunate incident but thankfully nobody got injured."

With collision investigations, the NYPD handles all criminal aspects of

the investigations, while NYC Department of Transportation (DOT) reviews the street design at the locations of such crashes. We reached out to DOT for more information on whether the road design was a factor.

A DOT spokesperson later said that parking at the corner [of the Henry Hudson Parkway West service road, southbound, before the bend by Kappock Street] is not new, and was temporarily removed while MTA Bridges & Tunnels made improvements to the nearby pedestrian and bicycle path. The spokesperson added that the contractor is responsible for returning parking spaces after work is complete.

Assemblyman Jeffrey Dinowitz (A.D. 81), who represents the local area, said on Friday, "I was on the scene of the BXM1 bus crash with Council Member Eric Dinowitz. Thankfully, there were no customers on board and no injuries. The bus operator was safely removed by the FDNY and is unharmed. The crash happened while the driver tried to go around

a double-parked car."

#### By SÍLE MOLONEY Charges Against Former Lt. Gov. Dropped

Federal prosecutors announced on Friday, Jan. 17, that bribery and related charges brought against former Democratic New York Lt. Gov. Brian Benjamin in April 2022 were dropped following a review of the case and in light of the death of a Bronx-born cooperating witness, Gerald Migdol, 73, who was also a co-defendant. Benjamin was charged on April 11, 2022 for conspiracy to commit bribery and honest services wire fraud, bribery, honest services wire fraud, falsification of records, and aiding and abetting.

In light of the death of Migdol on Feb. 9, 2024, and a review of the case, they said U.S. District Judge J. Paul Oetken approved dismissal of the federal charges against Benjamin, 48, a former State senator representing Upper Manhattan, including Harlem. The court heard that the government determined it could no longer prove the charges beyond a reasonable doubt.

In Migdol's obituary, he was described as "a community-minded businessman, attorney, philanthropist, and beloved family man" who was born in The Bronx on Feb. 10, 1950, and raised in Queens. Some media outlets described Migdol as a Harlem real estate mogul.

According to a 2021 990 tax form, Migdol was president of Friends of Public Schools, Harlem, Inc, a nonprofit with an address at 223 West 138th Street in Harlem. According to the same filing, the organization's primary, taxexempt purpose was "fundraising and providing resources to public schools and students in Harlem." The organization's book-keeping was listed as being handled by Migdol. Net assets for 2021 for the nonprofit amounted to \$21,144.

According to a 2022 990 tax filing for another 501(c)(3) entity, an exempt private foundation, "The Migdol Family Foundation Inc, aka The Daniel Migdol Memorial Fund," on which Migdol served as an officer/director or other, net assets amounted to \$378,957. Corporate stock investments amounted to \$308,164 at year-end, while disbursements for charitable purposes amounted to \$17,525 at year-end.

On April 12, 2022, federal prosecutors alleged Benjamin struck a deal with an unnamed real estate developer, referred to in the indictment as CC-1, and allegedly directed a \$50,000 state grant to a nonprofit controlled by CC-1 in exchange for tens of thousands of dollars in campaign contributions from CC-1.

They also alleged Benjamin repeatedly lied to cover up the bribery scheme, including by falsifying campaign forms and misleading city regulators. They also alleged Benjamin repeatedly lied on the forms he filled out before he was appointed lieutenant governor.

Benjamin received the endorsement of the Bronx County Democratic Party in February 2021 in his bid to win the seat for New York City comptroller, a race ultimately won by now-incumbent, Brad Lander. Representatives for the Party said at the time of Benjamin's endorsement that the Party was committed to helping elect Democrats across the borough who "continue to fight for progress and for the residents of the community."

The party's representatives said the endorsement was based on Benjamin's extensive experience handling investments, and his background in finance, a crucial skill, they said, for the job of city comptroller. Combined with his work as chair of the Budget and Revenue Committee in the state senate, they said Benjamin was the only candidate with the ability to handle investing the City's money while protecting the pensions of retirees.

Benjamin denied any wrongdoing and entered a not guilty plea. Reacting to the dropped charges, he said in part, "I would like to thank the present leadership at <u>@SDNYnews</u> for reviewing this case and deciding to dismiss the charges in its entirety today. I want to thank my legal team, family, friends and community for all of their unwavering support."

Meanwhile, an excerpt from Migdol's obituary reads, "Gerald devoted countless hours to supporting Harlem's public schools by providing educational resources and assisting Harlem Hospital with vital supplies."

#### AOC, Espaillat Urge New Yorkers to Know their Rights

Following the inauguration of Donald Trump as the 47<sup>th</sup> president of the United States on Jan. 20, and the likelihood of ICE raids stemming from his immigration policy, Reps. Adriano Espaillat (NY-13) and Alexandria Ocasio-Cortez (NY-14), and others are urging immigrant New Yorkers to know their rights.

They said immigrant New Yorkers do not have to open the door to, or consent to a search by ICE officials without a warrant, that the 5<sup>th</sup> Amendment protects their right to remain silent, that ICE officials cannot enter employeeonly areas of the workplace, and that immigrant New Yorkers are not obligated to provide personal information to ICE. They added that immigrant New Yorkers should not lie, do not have to sign anything or hand over any documents, and have the right to speak to an attorney.

#### Bedford Park Man Reported Missing

The NYPD is asking for the public's help locating a Bedford Park man, Theodore A. Rourke, 43, who was already being searched for by the Riverhead Town Police Department in Upstate New York after he was reported missing by his mother, Judith Leavitt of Riverhead, NY, on Friday, Jan. 9. They said she last had contact with Rourke in mid-December.

Rourke is described as a white male, 5 feet, 8 inches tall, weighing 140 pounds, with balding, brown hair. Police said he was last seen in the area of 2700 Marion Avenue in Bedford Park in mid to late December 2024 and has lived at 2700 Marion Avenue for roughly the last seven years. They said although no foul play is suspected, Rourke is diagnosed with schizophrenia.

On Saturday, Jan. 18, the NYPD said Rourke was last seen leaving his home on Tuesday, Dec. 24, 2024, at around 8 p.m. They said he was last seen wearing a blue jacket and blue jeans and asked anyone with information to call the NYPD's Crime Stoppers Hotline at 1-800-577-TIPS (8477) or for Spanish, 1-888-57-PISTA (74782). ## Mayor Talks Up Bronx Jobs after Trump Meeting

Amid criticism from some that his meeting with now-U.S. President Donald Trump, held Friday, Jan. 17, was used to discuss his pending federal legal case of alleged bribery in the context of prior election campaign financing, and to which he has pleaded not guilty, NYC Mayor Eric Adams refuted suggestions the meeting was used for this purpose and said the discussion, among other topics, focused on bringing manufacturing jobs to New York City, particularly in The Bronx.

'President Trump and I had a productive conversation about New York's needs and what's best for our city, and how the federal government can play a more helpful role in improving the lives of New Yorkers," the mayor said. "While we briefly touched on a number of issues, we specifically focused on the ceasefire agreement between Israel and Hamas, and how it will have a positive impact on public safety in our country; how we can bring manufacturing jobs back to New York, particularly in The Bronx; and how we can continue to make federal investments in New York City, especially when it comes to infrastructure."

Adams added, "To be clear, we did not discuss my legal case, and those who suggest the mayor of the largest city in the nation shouldn't meet with the incoming president to discuss our city's priorities because of inaccurate speculation, or because we're from different parties, clearly care more about politics than people."

The mayor continued, "Like I've always done, I will take every opportunity possible to advocate for New Yorkers and our city, and after our discussion, I strongly believe there is much our city and the federal government can partner on to make New York City safer, stronger, and more affordable. I thank President Trump for his time and attention and look forward to working with him to benefit all New Yorkers."

Bronx City Councilman Kevin Riley (C.D. 12), who represents much of the North Bronx, responded to Adams, saying, "Would love to hear more about this convo <u>@NYCMayor</u>."

The day before the Trump meeting, the mayor announced the release of the \$114.5 billion fiscal year

2026 preliminary budget. According to City officials, the budget makes "sound investments" that will keep the City's subways and streets safe, bring tax relief to working-class New Yorkers, beautify parks, and make communities safer.

On Friday, the NYPD released the following statement regarding additional police presence on the City's subway system. "The NYPD will be rolling out the ambitious plan to put two officers on every overnight train in phases. Phase 1 will officially begin on Monday and include the first 100 officers."

The department added, "Additional phases will be rolled out over the coming weeks with the expectation that the full operation will be complete by the end of the month. This is a massive undertaking that involves specialized training as well as logistics and resource management. We appreciate the governor's support in keeping New Yorkers safe."

Meanwhile, of the budget announcement, City officials said that investments in various sectors were made possible through what they said was the Adams administration's "ongoing, strong, fiscal management," including \$3.4 billion in total savings" and a "robust economy."

They said the Adams administration's policies had set the stage for the City's economic growth and helped increase tax revenues, adding that the asylum seeker reforecast saves the City \$2.4 billion over two fiscal years, bringing total asylum seeker savings over three fiscal years to \$5.2 billion.

Reaction to the budget was mixed, both positive and negative. New York's

civil legal service providers, for example, called on the mayor to fix what they said was the City's broken contract and payment process, saying payment delays jeopardize nonprofits' ability to deliver on the mayor's stated goals of helping tenants, low-income people, and new arrivals.

The Legal Aid Society, Lawyers For Children, Human Services Council, Mobilization for Justice, The Neighborhood Defender Service of Harlem, the New York Legal Assistance Group (NYLAG), TakeRoot Justice, The Bronx Defenders, Legal Services NYC, Brooklyn Legal Services Corporation A, CAMBA Legal Services, New York Lawyers for the Public In-

terest, and The New York Immigration Coalition said, "Like Mayor Adams' State of the City address, his Fiscal Year 2026 Preliminary Budget announced today includes various initiatives that are dependent on non-profit contractors to implement."

They added that what they saw as the mayor's reliance on nonprofits revealed a "problem of the mayor's own making" that will delay his agenda from moving forward i.e. "the City's broken payment and contracting process."

"Nonprofits either cannot submit or still have not received payment on current invoices for payment on any approved baseline contract with the Human Resources Administration – the

department responsible for the majority of the City's social services programs, which includes critical housing and immigration-related programming," they said.

They went on to say that the "current egregious payment delays" have some providers "on the brink of bankruptcy," soon unable to carry out the administration's priorities, and ultimately harming New Yorkers who desperately need these services.

"Mayor Adams needs to recognize that his agenda and priorities are being stymied by his refusal to fix a failed process he campaigned on reforming," they concluded. "Many of the proposals he announced last week and today are necessary and will benefit many of the communities we serve, but they will fall flat if the City persists in its failures to pay the nonprofits tasked with implementing them."

The mayor attended Trump's inauguration ceremony in Washington D.C. on Jan. 20. Adams is deemed innocent of the bribery and related charges unless and until convicted in a court of law. Meanwhile, NPR reported that the president received an unconditional discharge for his criminal conviction in New York on Jan. 10, meaning he will not face fines, prison or any other penalties in relation to the 34 felony counts of falsifying business records to conceal a payment to adult film star, Stormy Daniels. Trump plans to appeal the conviction.

#### University Heights Armed Robbery of Store with Machete

The NYPD is asking for the public's help identifying and locating the person seen in the accompanying photo below who they say is wanted for questioning in connection to a robbery that occurred in University Heights. Police said that on Tuesday, Dec. 17, 2024, at around 10 a.m. inside a business (deli) located at 51 West 183rd Street, an unidentified person displayed a machete and demanded goods from the employee.

They said the suspect stole store merchandise and then fled on foot to parts unknown. They said there were no reported injuries. Police said the person sought is described as male, has a light complexion, is around 5 feet, 7 inches tall, and weighs 150 pounds. They said he was last seen wearing a black hat, a multi-colored sweatshirt, black pants, and grey sneakers.



#### Norwood Man Gets 40 Years to Life for Shootings

Bronx District Attorney Darcel D. Clark announced on Jan. 6 that a Norwood man was sentenced to 40 years to life in prison after he was convicted of second-degree murder and additional charges for fatally shooting a bodega clerk and wounding the store's owner in Mount Eden in 2021. Officials from the Bronx DA's office said the defendant, Tykwan McLeod, 49, last of Dekalb Avenue in Norwood, was additionally sentenced on Jan. 6 to five years post-release supervision after being convicted by a jury of second-degree murder, attempted assault in the first degree, and second-degree criminal possession of a weapon by Bronx Supreme Court Justice Ralph Fabrizio.

According to the investigation, on Feb. 16, 2021, at around 8.40 p.m., the defendant entered K's Convenient Deli at 8 East Mount Eden Avenue and immediately shot the store clerk, Donte Thomas, 33, in the face, killing him instantly. The court heard that as Thomas fell, McLeod shot him twice, but as he attempted to flee, the bodega owner grabbed him. Prosecutors said that as the owner did so, McLeod then also shot the owner in the chest at point blank range. They said the owner and another employee then wrestled the gun away from McLeod, and an off-duty, NYPD auxiliary officer then picked it up from the floor.

\$2,466 IN CASH found in or around April 2024 by law enforcement in the vehicle of a former NYC Department of Correction officer, Ghislaine Barrientos, who has pleaded guilty to accepting bribes from an inmate in exchange for drug smuggling into Rikers Island jail.

#### Former Female DOC Officer Pleads Guilty to Bribery

Federal prosecutors announced Wednesday, Jan. 8, that Ghislaine Barrientos, a former NYC Department of Correction (DOC) officer, pleaded guilty to bribery in exchange for smuggling cocaine into Rikers Island jail. Edward Y. Kim, now-former acting U.S. attorney for the Southern District of New York, said Barrientos pleaded guilty before U.S. District Judge Gregory H. Woods and is scheduled to be sentenced in April.

The court heard that the former DOC officer conspired with others to smuggle contraband, including cocaine, smokeable synthetic cannabinoids (known as "K2"), and food to inmates housed at the Robert N. Davoren Complex on Rikers Island in exchange for thousands in cash bribes.

For example, on April 11, 2024, CC-1, an associate of an inmate ("Inmate-1") and Barrientos discussed CC-1 sending Barrientos a package through a delivery service. On April 15, 2024, surveillance footage shows Barrientos entering Inmate-1's cell, where the surveillance footage could not capture her actions. Two days later, DOC searched Inmate-1's cell and recovered sheets of paper that tested positive for cocaine.

The court heard that on April 24, 2024, CC-1 sent Barrientos another package using the delivery service. When Barrientos went to work later that day, a drug-detecting canine alerted officials to the presence of narcotics. DOC employees searched Barrientos's belongings and found around 10 sheets of paper that tested positive for K2.

Barrientos later falsely told law enforcement that no inmates had ever asked her to bring them contraband. Prosecutors said when officers searched Barrientos's vehicle, they recovered additional sheets of paper, as well as around \$2,466 in cash.

Barrientos, 37, of Mount Vernon, NY, pleaded guilty to one count of conspiracy to commit federal program bribery, which carries a maximum sentence of five years in prison. The statutory maximum sentence is prescribed by Congress and is provided for informational purposes only. Any sentencing of Barrientos will be determined by the judge.



#### Man Charged with Fatal Stabbing of 14-Year-Old Boy

A 29-year-old man, Waldo Mejia, with a history of violence and mental health issues, has been arrested and charged with murder for the fatal stabbing in Mott Haven on Friday, Jan. 10, of 14-yearold Caleb Rijos on his way to school, police said. Caleb grew up in Wakefield but later moved to Mott Haven. Police said they believe Mejia, seen in the accompanying photo above, may also be responsible for a prior stabbing of a 38-year-old male, Hispanic victim in Mott Haven earlier this month.

They said on Jan. 10 at around 9.33 a.m., police responded to NYC Health and Hospitals/Lincoln, located at 234 East 149th Street in the South Bronx, for a report of a 14-year-old boy in critical condition who was being treated for multiple stab wounds to the chest. They



said hospital staff later pronounced Caleb deceased.

They said further investigation determined an unprovoked stabbing occurred in front of 300 East 138th Street in Mott Haven, while Caleb had been standing alone on the sidewalk and that the perpetrator had fled the scene. They said Caleb lived on nearby Alexander Avenue. Friends later said he had grown up off 224th Street and Bronxwood Avenue in Wakefield and had attended middle school nearby.

NYPD Chief of Detectives Joseph Kenny said the stabbing of the 38-yearold occurred on Sunday, Jan. 5, on the corner of East 138th Street and Third Avenue [also in Mott Haven] as the victim was walking downstairs to the subway, adding he had been approached from behind by an unidentified male who stabbed him once in the left arm. He said the victim was removed to a local hospital, where he received several stitches.

Kenny said once police obtained video and photographs of Caleb's stabbing, they shared them with all officers and a Transit Bureau officer recognized Mejia from the Jan. 5 incident and notified detectives. He said Mejia was described as male, Hispanic, with a slim build, around 6 feet, 3 inches tall, was wearing a black jacket, gray pants, and black sneakers with a white stripe.

They said patrol officers were posted near Mejia's home, and just after midnight on Saturday morning, they spotted him returning to the building, approached him, and detained him without incident. They said he was wearing the same sneakers and pants he had worn during the homicide and was in possession of a bloody knife.

Police said Mejia, also of Alexander Avenue, was later charged with seconddegree murder, first-degree manslaughter, and fourth-degree criminal possession of a weapon. Kenny encouraged the public to call the tip line on 1800-577-TIPS if anyone had any additional information on the two stabbings. ## DOB & ACC Work to Rescue Pets after Allerton Fire

#### By SILE MOLONEY

Following the horrific, 5-alarm fire at 2910 Wallace Avenue in the Allerton section of The Bronx on Friday, Jan. 10, which displaced hundreds of residents amid frigid temperatures, NYC Department of Buildings (DOB) workers carried out some ad hoc pet rescue at the now-vacated building.

On Wednesday morning, Jan 15, five days after the fire broke out, DOB Principal Engineer Ben Sippel worked with Animal Care Centers of NYC (ACC) to help rescue Daisy, a cat stranded in one of the apartments vacated after the fire. "We've since helped reunite Daisy with her family and can confirm that, while a little bit cranky, she is warm and has a full belly," a DOB spokesperson said.

"In emergency situations where Vacate Orders are placed on a building, instances like this do occur and we work tirelessly to ensure that stranded pets are reunited with their families!" According to DOB, Sippel also saved and reunited a pet turtle from the building with its owner.

Another pet rescue took place on the fifth floor of the building on Thursday, Jan. 16, when Sasha, another house cat, was reunited with her owner, after she was stranded in the building, DOB officials said. They added that DOB and ACC worked together to set up other "traps" inside the building to catch other pets that may have been wandering around lost.

"The ACC team have been putting a lot of work [in] at this location, helping to reunite owners with animal members of their family," said Andrew Rudansky of DOB. "They deserve a ton of credit for these efforts."

DOB officials said each day after the fire occurred, DOB staff con-

ducted extensive structural stability inspections of the building, coordinating with other City agencies and the building owner's representatives as they began clean-up operations and work to make the building safe, and to allow tenants to start retrieving necessary items from their homes.

They said DOB would continue to maintain a presence at the building, monitoring the progress of the clean-up operations, and pushing the owner to start the needed repairs to get the displaced tenants back home.

*Norwood News* was previously advised by the FDNY Foundation that if residents are not home when a fire breaks out and if they have pets, owners can place a notice somewhere inside the apartment near the apartment door in large lettering

## CC Sabathia Selected for Baseball Hall of Fame

The National Baseball Hall of Fame and Museum announced on Tuesday, Jan. 22, that three players from the modern era, including New York Yankee pitching legend, CC Sabathia, were selected to be inducted this summer into the National Baseball Hall of Fame. The other two are Ichiro Suzuki and Billy Wagner. All three were selected by members of the Baseball Writers' Association of America.

In the announcement, Hall of Fame officials wrote, "CC Sabathia, Ichiro Suzuki and Billy Wagner earn baseball immortality and join Dick Allen and Dave Parker in the Class of 2025."

Hall of Fame officials said Sabathia, 44, was inducted in his first year of eligibility, receiving 342 votes or 86.8% of all votes. They said the pitcher began his 19-season career with the Cleveland Indians in 2001, and in 2008, he joined the Milwaukee Brewers.

They said he joined the Yankees for the 2009 season, where the team enioved a World Series victory, and Sabathia was named the 2009 American League's Most Valuable Player

(MVP). They went on to say that Sabathia retired as one of only six pitchers in history with at least 250 victories, a .600 winning percentage and 3,000 strikeouts.

Meanwhile, they said Ichiro, 51,

becomes the first Japanese player to enter the National Baseball Hall of Fame. He also had his rookie season in 2001, joining the Seattle Mariners and was named the American League's Most Valuable Player and Rookie of the Year the same year. They said during his 19-year career, Ichiro also played for the Yankees and the Miami Marlins.

They said the 2.31 career ERA for Wagner, 53, is the lowest among retired, lefthanded pitchers with at least 500 innings pitched in the liveball era (post 1920). Wagner played with the Houston Astros, the Philadelphia Phillies, the New York Mets, the Boston Red Sox, and the Atlanta Braves. His career walks-plus-hits-perinnings-pitched ratio (WHIP) of 0.998 is lowest among all retired relievers with at least 700 innings pitched.

Reacting to the announcement, The New York Yankees posted on X, "Next stop: Cooperstown" in reference to the New York town, where the Hall of Fame ceremony



will take place in the summer. The following day, they posted a photo of Sabathia with the caption, "CC will continue to #RepBX in Cooperstown." They also posted a photo of Sabathia with a quote from him taken from his plaque at Monument Park in Yankee Stadium.

It reads, "This is home, The Bronx. I found a home in The Bronx, and I don't think I'll ever leave this city. So, I think it's only fitting." Meanwhile, Sabathia, himself, reacted to the honor, writing on social media, "Thank you for all the love and support around being elected to the Hall of Fame 2025 class. It truly means everything to me and my family. I realize how special (the) first ballot is, and very appreciative of all the voters who recognized my accomplishments."

He added, "Getting to share that moment with all my people is what matters the most. Next stop, Cooperstown." The National Baseball Hall of Fame and Museum Induction Weekend will be held July 25-28 on the grounds of the Clark Sports Center in Cooperstown, NY.

Hall of Fame officials also said Dave Parker, a former player with the Pittsburgh Pirates, was selected in December 2024 by the Classic Era Committee to be inducted into the Hall of Fame, along with Dick Allen, a former player with the Philadelphia Phillies, who died in 2020 at the age of 78.

Finally, Tom Hamilton, 52, a sportswriter with the Washington Post, will be presented with the Ford C. Frick Award for baseball broadcasting during the upcoming ceremony, along with Thomas Boswell, who spent 52 years as a columnist with the Washington Post before retiring in 2021. Boswell was selected the 2025 winner of the BBWAA Career Excellence Award.



## Mental Health Challenges How to Keep Everyone Safe

Hull Avenue in Norwood, was arrested on Dec. 19, 2024, and charged with public lewdness.

On Feb. 6, 2021, *Norwood News* was at the scene after a 67-year-old man was slashed across his right ear and neck with a boxcutter on East Gun Hill Road and Hull Avenue allegedly by Dave Scafe, 48, another assisted living resident. It was reported at the time that the victim required 11 stitches to close the gash. At the time, *Norwood News* spoke with two additional male victims, a store employee and a business owner on East Gun Hill Road, who alleged they were also assaulted by Scafe, but apparently did not press any charges.

Ten days after Anderson's arrest, on Dec. 29, 2024, we visited the Hull Avenue building to try to speak with him. Once inside, a male employee located behind a glass partition said, "He doesn't have a phone." We asked if Anderson was home. The employee replied, "He should be up there; I think he's up there. He moves around. You know what this is, so he moves around a lot."

The employee confirmed the building was run by PCMH. We asked if, generally, residents are removed from the building if they're arrested. He replied, "He's here." When asked about Scafe, the employee replied, "He's still here."

*Norwood News* first visited the 8-story building on Feb. 14, 2021, when a woman who identified herself as a manager, said, "This is a mental health fa-

cility." When asked about Scafe's arrest, she replied, "We don't know anything about that and if we did, I wouldn't be able to give the information about that

> because that's his personal business."

In 2021, an extract from PCMH's website explained that clients were welcome to stay at the facility for as long as they wanted. We asked the manager if a resident would be removed if they were convicted of a crime. She responded. "That's between him and the company; we don't make the final decision. There's a whole upper management and the legal team; we have nothing to do with it." The extract in question has since been removed from the website.

PCMH has ten locations in The Bronx, four in Manhattan and three in Brooklyn. The Bronx sites include Bronx Park East, Crotona Park, Grand Concourse, Hull Avenue, Teller Avenue, Marion Avenue, Washington Avenue and Shakespeare Avenue.

On Feb. 14, 2021, *Norwood News* contacted Scafe via text to ask him about his arrest. He replied, "I don't know of any such thing." He added, "Police are in the business of telling lies." We attempted to reach Scafe again in January this year but were unsuccessful.

According to the Bronx District Attorney's office, Scafe has been on "supervised release" since shortly after his 2021 arrest and had returned to his Hull Avenue home. The Bronx District Attorney's office also confirmed that Scafe, who originally faced ten charges, including assault, menacing and harassment, pleaded guilty to second-degree assault, and fourth-degree criminal possession of a weapon, and was expected to be sentenced on Feb. 11, 2025.

Outside the Hull Avenue building, on Dec. 29, 2024, we asked a female passerby who lives on the block if there were any problems with the building. She replied, "Sometimes you hear screaming upstairs."

When informed of the 2021 stabbing, the woman replied, "Yeah, I heard about that." Asked if she knew if Scafe was still living in the building, she said, "He's still alive. I think so, yeah." When shown the photo of Anderson circulated prior to his arrest, the woman said, "I don't know him."

When informed Anderson was arrested for masturbating on a subway

train, she gasped, "Oh!" When informed he was still living in the building, she said, "Really? That's not good." Asked if she thought residents should be removed from the building if arrested, she said, "Yeah, they should."

According to PCMH's website, the Hull Avenue building is a partnership with a host of other government agencies and programs, including OMH, DHS, NYC Department of Health and Mental Hygiene (DOHMH), NYS Homeless Housing Assistance Program (HHAP), and NYS Housing Finance Agency (HFA).

After repeated attempts to obtain information and a comment about the Hull Avenue building, Mitchell Abramson of DHS responded on Tuesday, Jan. 21, saying, "DSS / DHS doesn't oversee this site." *Norwood News* also reached out to DOHMH for comment. We had not received a response as of press date.

In a review of PCMH posted in February 2023 on Indeed.com, one former employee of the PCMH Grand Concourse facility alleged, "This is a nonprofit that doesn't care about their housed tenants or staff; people in high positions are very cutthroat, with no integrity." The unidentified poster also alleged, "If a tenant spits on you or assaults you, there's nothing you can do, or you'll be fired."

After numerous calls to PCMH's executive assistant John McMasters on Tuesday, Jan. 21, "Christina" of PCMH, who said she oversees the residential division, fielded questions on PCMH's business practices.

She said PCMH is overseen by both the OMH and "DOHC" and was unable to speak about specific clients. She said PCMH houses clients with mental health issues, as well as working families but she could not give a ratio of clients versus working families at the massive, 8-story building.

Asked about the process for evicting a client, Christina said, "We do have to follow the same exact housing laws as you and I have, which means we have to go through very, very lengthy court proceedings."

Referencing the eviction moratorium in place amid the COVID-19 pandemic, Christina added, "And we share in the same frustration when we come across clients that really need to be held accountable for their actions, and we want to protect our buildings and the community." She added, "And it takes years for us to evict tenants that are deserving of being evicted."

Regarding the post where a former employee of the Grand Concourse facility alleged PCMH employees had no protection against assaults by clients, Christina said, "That is 100% not accurate and it's actually the opposite. We always encourage and support our staff to press charges if they are assaulted." She added that 50% of the time staff members decline to press charges against a resident because doing so would damage the relationship between the staffer and the client, or because the staffer doesn't want to go through with the required lengthy legal process.

Anderson is deemed innocent unless and until convicted in a court of law.
