

Federal agents from a host of different law enforcement agencies converged last month on at least three locations in The Bronx, one in Manhattan, and another in Queens in efforts to detain undocumented migrants.

The raids came days after Republican U.S. President Donald Trump signed an executive order on Jan. 22, suspending "the physical entry of aliens engaged in an invasion of the United States through the southern border." This order had, in turn, followed a prior Jan. 20 executive order authorizing the detention of "unregistered aliens," among other immigration-related actions.

According to posts on X by the U.S. Drug Enforcement Agency (DEA) and newly confirmed U.S. Department of Homeland Security (DHS) Secretary Kristi Noem, various raids took place before dawn on Tuesday, Jan. 28, in New York City. Agents from U.S. Immigration and Customs Enforcement (ICE)'s Enforcement and Removal Operations division, U.S. Homeland Security Investigations (HIS), DEA, U.S. Customs and Border Protection (CBP), the U.S. Secret Service and the NYPD's Special Operations Division entered at least five City locations and took several people into custody.

At just after 7 a.m. on Tuesday, DEA New York posted on X, "Happening now, #DEANewYork participated in an operation supporting @DHSgov, along with our @TheJusticeDept & other federal law enforcement partners, with their #immigra-(continued on page 15)

## Mayor Appoints Velázquez to Tenant Protection Role

Embattled New York City Mayor Eric Adams last month announced 17 new appointments and promotions within City government to fill various vacancies. The appointments come as the City Hall exodus continues, and amid a federal bribery probe into the mayor's 2021 election campaign that continues to cast a shadow over his administration. The mayor denies any wrongdoing and his case is ongoing.

In a press release dated Tuesday, Jan. 28, Adams announced he has appointed the former Bronx City Council Member for C.D. 13, Marjorie Velázquez, as director for tenant protection. According to the press release, Velázquez most recently served as vice president of policy for Tech: NYC "where she worked to bridge the gap between City Hall, Albany, and New York's fast-growing tech sector."

The release continued in part, "She championed several key initiatives, including a landmark ruling mandating a minimum wage for gig economy workers, securing funding for public transit and safety improvements, and passing bills to strengthen tenants' rights."

Velázquez served as the Democratic council member for Council District 13 from January 2022 to December 2023 before losing to Republican, Kristy Marmorato, the first time a Republican defeated a Democrat in a Bronx election in nearly two decades.

A female, East Bronx resident who declined to be identified for this story said she had opposed the stand taken by Velázquez on the Bruckner Boulevard upzoning housing development in Throggs Neck, as well as what the resident alleged was Velázquez's position on the proposed "Just Home" housing project.

Some residents opposed the upzoning development because of the perceived impact upon traffic, and insufficient policing, schools, and parking to cater for the influx of new residents. Meanwhile, the Just Home project was a proposal to create around 70 studio and two-bedroom apartments, as well as access to onsite social services, on the grounds of Jacobi Medical Center in Morris Park for formerly incarcerated New Yorkers with life-threatening medical conditions.

Referring to Velázquez, the resident told *Norwood News*, "She lost her seat due to the upzoning and the community outrage of Jacobi Building 2. She didn't listen to the people, and she stabbed

them in the back, so they tossed her out to the curb."

When *Norwood News* interviewed Velázquez about the Just Home project in 2023, she said she had always been against it, adding it had been initiated under her predecessor, Mark Gjonaj, and under former NYC Mayor Bill de Blasio. "Unfortunately, the community was never engaged and so, you can't blame them for being frustrated, angry, because they were left out of a very important conversation," she said at the time.

Asked for her views on Velázquez's latest role at City Hall, the same female resident said, "It is just political nepotism... and he [the mayor] continues to hire people with no skills or experience."

According to one biography, Velázquez holds a degree in Finance and Accounting from NYU, worked in several corporate finance, budgeting, and accounting positions, where she designed and implemented accounting strategies for various regions around the world.

She also served as a volunteer on the boards of Amplify Her and the Broad Room, both of which are dedicated to empowering women through civil and political engagement. Additionally, she served on the board of St. Joseph's School for the Deaf Children's Fund, the Bronx-Westchester advisory board of Services for the Blind and Visually Impaired, and with the Bronx River Alliance, which advocates for environmental justice and resiliency.

According to Adams' administration officials, as of 2023, there were 3,705,000 total housing units in New York City and of those, 2,324,000 were rentals and 1,109,000 were owner-occupied. They said over 40% of all renters in New York City spend 30% or more of their income on rent, and one fourth of renters spend half of their income or more on rent. They said in 2023, the median monthly rent was \$1,641.

According to City officials, a tight housing market remained in New York City in 2023 with a citywide rental vacancy rate of 1.41%, below the 5% threshold required for rent regulation to continue under State Law. They said this translated into the availability of just 33,210 rental units out of more than 2.3 million rental units citywide. They said stabilized vacancy rates on the whole were 0.98%, while private, non-regulated units were vacant at a rate of 1.84%.

The Mayor's Office to Protect Tenants (MOPT) was established in January 2019, when then-Mayor Bill de Blasio signed Executive Order No. 39 to create the office and coordinate the City's tenant protection efforts.

On Friday, Jan. 31, *Norwood News* reached out for comment to the Office of City Council Member Pierina Sanchez (C.D. 14) who sits on the Council's Committee on Public Housing. [The council member is on maternity leave.] On Monday, Feb. 3, a staffer replied, "Unfortunately, we weren't able to meet your deadline." We also reached out for comment to Velázquez and to local housing groups, Housing Justice for All and Met Council on Housing. We did not receive an immediate response.

Meanwhile, with the C.D. 13 seat up for grabs once again this year, Theona Reets-DuPont, a Democrat and former chief of staff for District 15 City Council Member Oswald Feliz, announced Jan. 10, that she is running to represent the district. "I will represent and serve the people of District 13 with the same energy and tenacity that characterized my public service over the last four years in the Bronx," she said.

Adams is deemed innocent unless and until convicted in a court of law.

## **FYFJC** Continues to Fight Human Trafficking

Freedom Youth Family Justice Center (FYFJC), which seeks to empower, strengthen, and stabilize victims and survivors of human trafficking and domestic violence, held a "Stars of Freedom" annual gala on Friday, Jan. 24, at Eastwood Manor in the Williamsbridge section of The Bronx. Founded by Monique Riley, CEO, in conjunction with her husband, Joseph Riley, executive director, the Freedom Youth team took some well-deserved time out to celebrate their hard work and honor survivors, friends and allies.

Among those honored on the night, following a beautiful, orchestral musical performance, an auction, dinner, and other performances and a House DJ, were State Sen. Nathalia Fernandez (S.D. 34), who represents much of the East Bronx, Rochelle Bent, MBA, founder and chief visionary officer of Curations by Chelle B, Franklyn Williamson, senior pastor and overseer of Gospel Tabernacle Church Apostolic, Joseph Riley, and Marilyn Ross-Moody, immediate past president of the greater Bronx chapter of The Links, Incorporated.

Also honored, among others, were Danielle King-Stennett of the Bronx alumnae chapter of Delta Sigma Theta Sorority, Alina Dowe, MBA, Bronx borough director at the Mayor's Community Affairs Unit, Desia Monsanto, MBA, assistant director of graduate practical training & career services at Monroe University, Joshua Lespier, BA, executive administrator at FYFJC, Lisa Dawson, president of the north Bronx branch of the National Council of Negro Women, and Pamela Damon, executive director of Not on My Watch.

Survivor Jakoyah Boford Stevenson spoke from the heart on the night about her journey leading up to her first interaction with Freedom Youth, and her experience thereafter. Addressing her fellow survivors in particular, Boford Stevenson said, "This is your night; you all look amazing! I'm glad you guys all showed up and came to show your support for Freedom Youth and for all survivors."

She continued, "I am here today to explain my situation. I was a victim of sex trafficking, and I wasn't taken serious. I wasn't given what I needed to be given in terms of support. When I came to Freedom Youth, they gave me everything I needed: support, emotionally and mentally. They made sure I was mentally

alright, even though others would just shrug it off, [saying], 'Okay, she's kind of having a panic attack. Okay, she's melting down. She's just acting erratic.'''

Boford Stevenson went on to say, "In all reality, every survivor needs somebody, that one person they could just go to, and use as an outlet and support, someone that can sit there and tell them it's okay, and I want to thank three actually, Mr. Joseph Riley, CEO Monique Riley, and Joshua, because they are the reason I got out of that situation, and I'm still fighting through it."

According to the Urban Resource Institute (URI), homelessness isn't just a housing crisis, it's a human trafficking crisis. A new report by URI and The Passage reveals that 74% of trafficking survivors in New York City experienced homelessness, and 31% were trafficked directly from shelters. URI officials said these alarming statistics spotlight a critical gap in the City's ability to protect its most vulnerable populations.

Key findings included that traffickers specifically target individuals in unstable housing situations, especially youth, LGBTQIA+ individuals and undocumented immigrants. Shelters often lack survivor-centered policies and sufficient space for single adult survivors. Investment in training and affordable housing can directly improve outcomes for survivors.

During her remarks, Monique Riley, founder and CEO of FYFJC, outlined how she and Lespier often venture out into the City in the middle of the night, working long, difficult hours, assisting victims of human trafficking escape from their traffickers and their circumstances. "I get in my car at three or four o'clock in the morning cause a parent called me frantic, looking for a child," she said, before acknowledging all her team and asking them to recognize each other's hard work. Meanwhile, Boford-Stevenson said of her recovery, "At the end of the day, I made it in 2025 and I got married. My husband stuck with me. Even through my trauma and being a sex trafficking victim, he understood. He grew with me. He made me open up more, and I thank my husband for that too. I want to say to everybody out there who doesn't know how to speak up as a victim and as a survivor, there's always somebody else out there to help you."

She concluded, "There's always that one person that will accept you, and is willing to learn you, to help you grow as a person. So don't stop fighting for your survival. Don't stop fighting. There's other people out there. You got to be strong and you're beautiful and resilient."

## **Two Residential Fires Displace Residents**

FDNY officials said there were no injuries reported following a residential fire at 3065 Grand Concourse in Bedford Park on Wednesday night, Jan. 29. FDNY officials said they received a call at 9.53 p.m. for a reported fire at the 6-story, multiple dwelling located between East 203rd Street and East 204th Street.

They said 12 units comprising 60 fire and EMS personnel responded to the scene, the fire was brought under control at 10.29 p.m., and the cause remains under investigation. We spoke to siblings, Jayden Pimental, 14, and his 21-year-old older brother who live on the sixth floor and asked them what happened.

"I was in my room," Jayden said. "My mom just came knocking on my door saying we need to go, leave and so, yeah, that's all I know." His older brother added, "Same thing; my mom called me. I was on the train. She said the building was on fire, so I came here as fast as possible." He added that he thought the fire was on the sixth floor as there was a lot of smoke in that area. Asked if everyone had been evacuated, he said, "Yeah, pretty much."

After the fire was extinguished and the FDNY allowed residents back in, the brothers were seen helping their grandmother walk back upstairs to their apartment. She appeared to be having some breathing difficulties. We also spoke to fourth-floor residents, Rose Singleton and Chris. "Luckily, our neighbors across the hall, God bless them, banged on our door because everybody in the apartment was asleep, so we just jumped up, grabbed the coats, put on any kind of

shoes, and ran out," said Singleton.

"As we were coming down, you saw the firefighters trying to break into the apartment on the third floor," she said, adding that it was very, very smoky. "As we were walking down, everybody was choking. People were trying to make sure the kids didn't run off, trying to grab pets," she said. Asked if an alarm went off, Singleton said it did and that it was the second fire to take place in the building.

Chris added, "The elevators are not working. [They've] been breaking down a lot lately." Singleton said as far as she knew nobody was hurt. "We do have a

> neighbor at the end of the hallway that has a disability. I haven't seen him, so I don't know if he was home or he's in the hospital, but I hope everybody got out. It looks like it."

The owner of the property, according to City records is Joshua Frankel. We asked residents if there were any heating problems in the building. Some said there were while others said there weren't. According to NYC Department of Building (DOB) records, an elevator violation is open for the property with civil penalties due. The respondent for the property is sometimes listed as Aqua 3065 GC LLC, 1651 Coney Island Avenue, Brooklyn, but the name and mailing address listed with the Department of State is Residential Management (NY) Inc. at the same Brooklyn address.

According to an Aug. 28, 2024, DOB inspection of the boiler, there were no defects. Meanwhile, according to a November 2024 DOB inspection of the elevator, a compliance report was accepted but with defects. Meanwhile, as of the date of the fire, there were 105 open violations and three open complaints for the building logged with NYC Department of Housing, Preservation & Development (HPD), though no complaints were heat-related. Some of the violations were for roaches and repairs. We've attempted to reach the management company for comment.

The Red Cross said one family, comprising two adults and a child were able to self-relocate with relatives and the Red Cross provided financial aid, blankets, food, clothes, and comfort supplies to the family. Anyone in need of assistance should call 1-877-RED CROSS (877-733-2767) and select Option 1 for help.

A separate residential fire broke out at 2587 Bainbridge Avenue in Fordham Manor on Friday, Jan. 31, and also resulted in no injuries (except to a pet) according to FDNY officials. They said the department received a call at 11.56 a.m. for a report of a fire/smoke in the 3-s-tory, multiple dwelling located on a corner opposite East 193<sup>rd</sup> Street. They said the fire was in the basement, 12 units comprising 60 fire personnel responded to the scene, and the blaze was brought under control at 12.53 p.m.

One resident at the scene was observed extremely distraught. Some other residents said the person's pet had either died or had been injured. Speaking in Spanish, another female neighbor who shared a video of the fire with us, said the blaze had worried her as it was so close to her own building.

She said a female resident of the affected building and her child entered the neighbor's building to escape the smoke, and added that she believed one dog had died in the fire. Also speaking in Spanish, another woman who was parked in the area and was blocked from exiting due to the number of fire units on the street said she was trying to get to a specific White Plains Road school for the deaf to pick up her child.

The Red Cross said they registered one family (two adults and four kids) for emergency assistance including financial assistance and temporary lodging following the fire. According to DOB, a partial vacate order now exists for the affected property. According to HPD, it has 44 open violations, at least one relating to hot water.

Meanwhile, there were no open HPD-related complaints. The building appears to be owned by BBJJ Holdings LLC, with an address at 4403 15<sup>th</sup> Ave., Ste 530, Brooklyn, NY 11219-1604. We've attempted to reach the property owner for comment.

#### **Concerns over Fire Hydrant** on Webster Ave

Some residents raised concerns over a seemingly almost empty fire hydrant located at Webster Avenue and East 201st Street in Bedford Park. A visit to the hydrant on Sunday, Feb. 2, showed the hydrant open with a slow flow of water pouring out.

#### **Trash Piles Up at Bainbridge Ave Fire Site**

Residents have complained about the build-up of trash at the site of the Oct. 10, 2023 Norwood commercial fire at 3117-3335 Bainbridge Avenue by East 206th Street. Norwood News has been trying for years to contact the owner of the property, Bainbridge Realty Associates LLC, with an address at 1122 Avenue J in Brooklyn, to no avail. We reached out to the Division of Corporations section of NYS Department of State and NYC Department of Finance for help contacting the owner. The former said our inquiry fell under "giving legal advice" which they are not authorized to give. They said the duties of the Division of Corporations are ministerial in nature and that it is a filing office, not a regulatory or enforcement office. The property owner's "statement status" shows a "past due date" according to NYS records.

Meanwhile, regarding the trash situation, NYC Department of Sanitation (DSNY) said they inspected the location on Jan. 27, confirmed it was private property and as such, the responsibility of the owner to clean. They added that although site sanitation is the owner's responsibility, when DSNY finds unsanitary conditions, they work with NYC Department of Health (DO-HMH) to have the site cleaned and start by requesting that a DOHMH Commissioner's Order to Abate be sent to the property owner.

They said they then return around two weeks later and if they still find unsanitary conditions, they issue a summons, schedule a cleaning and bill the owner for the work abating the health nuisance. They said in this case a DO-HMH letter has been sent. "Given that

the lot is fenced and locked, we will also have to pursue an Access Warrant," they said. "This may take several weeks, depending on whether the owner is responsive, but we are continuing to monitor in the meantime." They added that dead rodents should be reported to 311.

## Inside Broadway Hosts "You're a Good Man, Charlie Brown" at P.S. 78X

The nonprofit organization, Inside Broadway, kicked off its 2025 touring production of "You're a Good Man, Charlie Brown" at P.S. 78X, The Anne Hutchinson School, located at 1400 Needham Avenue in Williamsbridge, on Wednesday, Jan. 15. The 12-week touring production is currently bringing Broadway directly to 45 public schools across all five boroughs.

According to Inside Broadway, the nonprofit puts on 45-minute productions that are specially designed to fit into a class period and are created by theater professionals and performed by professional actors and live musicians.

'We believe that's really important because the higher the quality [of performers], the higher the quality it would bring to our students, and they get to see real professional theater here at their schools," McAllister said.

## A Healthier Heart, The Power of Plants

When it comes to taking care of our heart, what we put on our plate matters. Research has consistently shown that eating more plant foods and less animal foods can improve heart health, lower cholesterol, and even reduce the risk of heart disease. Plant foods are fruits, vegetables, whole grains, seeds and nuts, and beans and legumes. Animal foods include meat and fish, eggs, milk and foods made from milk.

A "Plant-Based Diet" describes eating mostly plant foods and smaller amounts of animal foods. You don't need to go vegetarian (no meat or fish) or vegan (no meat, fish, eggs, milk products) to improve your heart health! Eating more plants, in small ways, can make a big difference. The American Heart Association (AHA) emphasizes the importance of eating a variety of nutrient-dense plant foods. These foods are packed with fiber, antioxidants, vitamins and minerals that help lower blood pressure, reduce inflammation, and improve cholesterol levels. In contrast, a diet high in animal foods and processed foods is high in saturated fat, salt, and sugar and can lead to heart disease. An example of animal food is a bacon, egg, and cheese sandwich and an example of processed food is potato chips or snack cakes.

The American College of Lifestyle Medicine (ACLM) agrees and recommends plant-based diets as a powerful tool for both preventing and treating heart disease. Studies show that plant-based eating patterns are safe and effective for children and adults.

Looking to add more plant food and reduce animal food? Unlike vegan and vegetarian diets (no meat allowed), a plantbased diet allows you to focus of plants and still eat moderate amounts of your favorite meats and other animal products. It's more flexible and sometimes is called a "flexitarian" diet! Studies show that even reducing meat intake a few times a week and adding more plants can significantly lower the risk of heart disease.

#### **Getting Started:**

**Reduce the meat:** Serve yourself a smaller portion of meat at dinner (size

of your palm) and increase low-carb vegetables to two cups (size of two fists). Visit <u>https://www.nyc.gov/assets/doh/downloads/pdf/csi/obesity-plate-planner-13.</u> <u>pdf</u> for tips. This can be raw vegetables like salad, or steamed, boiled, or roasted vegetables with your favorite seasonings. Brightly colored fruits and vegetables like berries, spinach, and carrots are especially rich in heart-protecting nutrients.

The key is to make the veggies the star of your meals and to still enjoy the meat and starches. Let's make the most of those starches: Use brown rice or bulgur and whole grain bread in place of white rice and white bread for a fiber boost. Or enjoy sweet potatoes, pumpkin, or butternut squash as your starch.

Skip the meat: Start by doing "Meatless Mondays" (<u>https://www.mondaycampaigns.org/meatless-monday/recipes</u>) at dinner once or twice a week and exploring heart healthy recipes like quinoa-stuffed peppers or black bean tacos. If you have a favorite chili or stew recipe, try using lentil or beans in place of meat. Beans, quinoa, lentils and soy foods (Tofu, tempeh, and imitation meats) are all packed with plant protein (<u>https://www.heart.org/-/</u> media/Healthy-Living-Files/Infographics/Plant\_based\_protein\_sources\_infographic.pdf?sc\_lang=en).

Dairy: Consider plant alternatives to

dairy products, like using almond milk instead of regular milk in coffee, cereal or smoothies. Go nuts for healthy fats! Incorporate heart healthy fats from sources like avocados, walnuts, and olive oil instead of butter or processed oils.

Making these changes can be easy and budget friendly. Check out the ACLM sample menu plan at https://lifestylemedicine. org/wp-content/uploads/2022/07/Eatingon-Budget.pdf for a week's worth of simple, affordable plant-based meals. Additionally, the AHA has practical tips on meatless recipes at https://www.heart.org/en/ healthy-living/healthy-eating/eat-smart/ nutrition-basics/vegetarian-vegan-andmeals-without-meat to make transitioning to a plant-based diet easier. A diet rich in plants protects your heart, helps you lose or maintain weight, lowers risk of diabetes and improves energy levels.

Remember, the goal isn't perfection; it's progress. Whether you're ready to be a vegetarian or simply add more plants, every bite counts toward a healthier heart and a happier you. #### MTA/Bee-line Bus Drivers

I previously wrote about the problems I have had in recent times with the MTA/BEE-line bus drivers, how they seem rather hostile towards men of color on their buses, requesting without always saying a "courtesy ride" or free bus ride so to speak for disabled people, in my case, a middle-aged O.G. stricken with arthritis. Off the top of my head, I can share a list of at least some of the buses on which I encounter difficulties.

The BX40, which is also rather slow, takes a half hour to 45 minutes to reach its destination, which, in many cases, would be the Boston Road/Gun Hill section of The Bronx.

The W60 covers much of the same area and at times has the same problems with punctuality. They don't seem to care about their customers of color, let alone myself, whether disabled (even slightly) or not. They must learn to be very courteous and professional which, in many cases, they are not. It's rather pathetic!

I don't usually take the BX31 that much anymore. Yet when I did, the drivers were way too slow, as well as being belligerent and nasty to their fellow minority customers. When it comes to chivalry, that they are hired to serve anyone, disabled or not, I find a travesty.

The bottom line is that I think the MTA and the Bee-line bus services need to be checked regularly for their lack of professionalism and, quite frankly, I doubt that New York City Mayor Eric Adams and his rather corrupt administration will do much about it. I hope that even the Westchester politicians reconsider this and perhaps New York Gov. Kathy Hochul ought to be informed about this.


#### Kingsbridge Heights: Grou Sought for Assault & Robbery




#### Fordham Manor Theft of Woman, 85

of this musical legacy down to my cousins and my aunts and uncles, my Uncle Ronie, my Aunt Patsy, my Uncle Kenny and Aunt Beverly up in heaven."

The now five-time Grammy winner concluded, "This family means everything to me. It means everything to be able to highlight what I come from, the stock that I come from, and to be able to highlight who inspires me the most. Once again, all the nominees in this category, I love you! I love your music! Thank you, thank you for your contributions, for inspiring me, and I will see you soon. God Bless you all. Thank you."

Last year, Joy, 25, won her third Grammy for Best Jazz Performance, and in 2023, she won her first two Grammys for Best New Artist and Best Jazz Vocal Album.

This year, in the Best Jazz Performance category for new vocal or instrumental solo, duo/group, or collaborative jazz recordings, Joy, featuring Sullivan Fortner, beat fellow nominees, The Baylor Project for "Walk With Me, Lord (SOUND | SPIRIT)," Lakecia Benjamin, featuring Randy Brecker, Jeff "Tain" Watts and John Scofield for

"Phoenix Reimagined (Live)," Chick Corea and Béla Fleck for "Juno," and Dan Pugach Big Band, featuring Nicole Zuraitis and Troy Roberts for "Little Fears."

Meanwhile, in the Best Jazz Vocal Album category for albums containing greater than 75% playing time of new vocal jazz recordings, she beat fellow nominees, Christie Dashiell for "Journey in Black," Kurt Elling and Sullivan Fortner for "Wildflowers Vol. 1," Milton Nascimento and Esperanza Spalding for "Milton + esperanza," and Catherine Russell and Sean Mason for "My Ideal."

Joy [née McLendon] is also an alum of SUNY's Purchase College and was a relatively unknown jazz singer before she was awarded her first Grammy for Best New Artist in 2023.

## **ICE RAIDS** Feds Converge on Bronx as Immigration Raids Begin

tion enforcement efforts which resulted in the arrest of one for kidnapping, assault & burglary charges."

Noem joined agents on the raid, later posting on X, "Arresting some criminal aliens this morning in NYC – thank you to the brave officers involved." According to published media reports citing law enforcement "sources," agents first raided 1372 Ogden Avenue in the Highbridge section of The Bronx where Anderson Zambrano-Pacheco, 25, a suspected leader of the Venezuelan gang, Tren de Aragua, was taken into custody.

Pacheco is reportedly wanted in Colorado where he faces charges of kidnapping, burglary, and weapons charges. Media outlets also reported that raids were conducted at 660 Rosewood Street in Olinville and at 2075 Creston Avenue in Fordham Heights.

Later that day, New York City Mayor Eric Adams posted on X in reference to the raids, "Beforehand, I directed the NYPD to coordinate with DHS' Homeland Security Investigations, and other federal law enforcement agencies—as allowed by law—to conduct a targeted operation to arrest an individual connected with multiple violent crimes, both here in New York and in Aurora, Colorado, including burglary, kidnapping, extortion, firearms possession." He added, "As I have repeatedly said, we will not hesitate to partner with federal authorities to bring violent criminals to justice." Responding to Adams' X post, the Standing for Freedom Center posted an ad that read, "Like a plot to a dystopian movie, New York will now monitor social media writings, collect data, and use law enforcement to crack down on any expression it deems to be hate speech."

Trump's Jan. 22 executive order read, in part, "President Trump has further restricted access to the provisions of the immigration laws that would enable any illegal alien involved in an invasion across the southern border of the United States to remain in the United States, such as asylum."

Speaking through a translator, on Thursday, Jan. 30, a resident of the raided Creston Avenue building told *Norwood News*, "Criminals should be deported, but law-abiding citizens shouldn't be taken away."

Former state senator and councilman Ruben Díaz, Sr., a pastor with New York Hispanic Clergy Organization, Inc., who is a staunch Trump supporter who had joined him on stage during his Bronx rally in Crotona Park on May 23, 2024, also posted on X after the raids, and after it was announced law enforcement were given permission to enter "sensitive locations" amid the raids, such as houses of worship, hospitals and schools.

Díaz began, "I am among the people who strongly supported, supports, and will continue to support the Trump agenda of restoring order." However, he added, "We strongly believe that churches, synagogues, temples, mosques, or any houses of worship must be respected as sacred ground." Díaz said he wanted to see Trump "publicly clarify" his executive order.

Democratic Rep. Ritchie Torres (NY-15), who represents much of The Bronx, stretching from the northwest to the south, also reacted on X, writing, "I strongly favor surgically removing violent criminals, especially gang leaders, from The Bronx. If you are among the activists who want to open your homes and communities to violent gang leaders, you're more than welcome to roll out the red carpet for them. But we in the Bronx want them gone."

Speaking on 'PIX on Politics' on Friday, Jan. 31, Frank Tarentino, special agent in charge of the New York division of the DEA, said, "We are 100% targeting the worst of the worst." He added, "Maybe there's other people in that apartment and / or structure that *do* have immigration issues and in those instances, we will do our job" [as directed under Title 8 immigration laws].

The same day, *Norwood News* sought comment on the matter from the Office of City Councilmember Pierina Sanchez (C.D. 14), who recently gave birth and whose Bronx office is located around the corner from the site of the Creston Avenue raid. On Tuesday, Feb. 4, a staffer replied, "Unfortunately, we weren't able to meet your deadline."

Meanwhile, one female, Van Cortlandt Village resident said of the ICE raids, "I just think that these people are being treated very unfairly. As I said, they get up every morning and I take the train to go to work and they sit right next to me. They make contributions to this nation; not everyone is a criminal." Asked if she knew anyone in danger of deportation, the resident replied, "My sister is one of those people who is afraid because, unfortunately, my sister lost all of her citizenship documents during a move, and it's taken her so many years to replace just some of those documents. So, I'm concerned that she could be swooped up in all of this."

Several media outlets also reported that a Puerto Rican man who is also a veteran was the target of a raid by ICE officials inside a New Jersey seafood store last month. Several Bronx Democratic elected officials, as well as Bronx Community Board 7 (CB7) representatives, are encouraging residents who may be fearful of being confronted by ICE officials to know their rights.

Some elected officials are sharing information at their constituency offices in different languages. For example, immigrants are being informed that they have the right to remain silent, that they can ask ICE officials for both ID and documentation such as a federal arrest warrant.

They are also being informed that if ICE officials enter an immigrant's home without permission, the immigrant can say, "I do not consent to you being in my home," and if they start to search the home, the immigrant can say, "I do not consent to your search."

Immigrants are also being made aware that ICE officials cannot enter private, employee-only sections of a workplace, but can enter public sections, that residents have the right to an interpreter, an attorney, that they do not have to sign documents or answer questions before speaking with a lawyer, and that they can inform ICE officials of medical and / or childcare needs, as appropriate.

*Norwood News* is currently looking into allegations of an ICE raid on a Bx36 bus and at a Bronx homeless shelter and will share any updates we receive.
